


On June 13, 2016, the U.S. House of Representatives passed H.Res.343 condemning organ harvesting in China.

Over One Decade of Investigations on the CCP's Organ Harvesting from Living Falun Gong Practitioners

World Organization to Investigate the Persecution of Falun Gong (WOIPFG) was founded on Jan. 20, 2003. Our mission is to investigate the criminal conduct of all institutions, organizations and individuals involved in the persecution of Falun Gong; to bring such investigations, no matter how long it takes, no matter how far and deep we have to search, to full closure; to exercise fundamental principles of humanity; and to restore and uphold justice in society.

On March 9, 2006, the second day after allegations were reported in the media that the Chinese communist regime had been harvesting organs from living Falun Gong practitioners, WOIPFG launched a systematic investigation on Mainland China. As part of our continual investigative efforts over the last more than a dozen years, we've conducted tens of thousands of telephone investigations targeting 891 organ transplant hospitals and made multiple rounds of searches, studying and analyzing hundreds of thousands of media reports, medical papers, cached hospital webpages, and databases from more than 9,519 transplant medical specialists.

WOIPFG's investigations have reached even China's most senior leadership, including five standing committee members of the Chinese Communist Party Central Politburo and multiple high-ranking officials, such as a vice chairman of the Central Military Commission, a committee member of the Central Politburo, a defense minister, and a former head of the health division of the General Logistics Department of the People's Liberation Army.

The CCP's Genocidal State Crime of Organ Harvesting from Living Falun Gong Practitioners



Since 1999, the Chinese Communist Party (CCP) criminal group, headed by its former leader Jiang Zemin, has been manipulating the entire state apparatus, including the Party, the government, the military, the armed police, the judicial system and medical institutions, to carry out a genocidal massacre of Falun Gong practitioners through live organ harvesting for transplantation across China. - ◆Conclusion Four: The initial main source for the involuntary live organ donor bank in China is suspected to be the several million Falun Gong practitioners illegally detained for petitioning for their rights and freedom to practice Falun Gong.
- ◆Conclusion Five: Our analysis of a large quantity of data suggests that a massive number of Falun Gong practitioners have been slaughtered by the CCP through live organ harvesting.
